#### **Breast Cancer Awareness Month**

#### Don't Wait Until it's too Late

- Breast cancer is the second leading cause of cancer deaths for women in North Carolina.
- Each year over 6,000 NC women will be diagnosed with breast cancer and over 1,000 will die from the disease.
- Women in North Carolina have a one-in-eight lifetime risk of developing breast cancer.
- Annual screenings and breast self awareness exams finding changes in one's breast early is a useful tool.



#### **Breast Cancer Awareness Month**



#### **Common Risk Factors**

- Gender- simply being female
- Age 50 or older
- Under age 12 at onset of menstrual periods
- Over age 50 at onset of menopause
- Over age 30 when first giving birth
- Never having given birth
- Personal or family history of breast cancer
- Being overweight
- Genetic predisposition, such as certain mutations in BRCA1 or BRCA2 genes

#### **Breast Cancer and Depression Statistics**

#### **Breast Cancer and Depression Statistics**

- In the United States, about 264,000 people are diagnosed with breast cancer yearly. Studies show an average of 32% (84,480) of those with breast cancer also battle depression.
- Studies show that breast cancer causes more significant mental distress than many other diagnoses, regardless of the stage or prognosis. Depression and anxiety are the two most common mental health disorders among breast cancer patients.

#### **Survival Rates**

• One study has shown that breast cancer patients with depression are 39% more likely not to survive than those who don't battle depression.

### **Breast Cancer and Depression Statistics**

#### **Medications**

• The safety of antidepressant medications for breast cancer patients depends on their cancer treatment. Antidepressants such as Wellbutrin (bupropion), Zoloft (sertraline), Prozac (fluoxetine), and others may decrease the effectiveness of Nolvadex (tamoxifen), a type of hormone treatment.

# **URGENT** Network Need: Providers to Complete Multidisciplinary Evaluations

- Vaya has an urgent need for network providers who can complete multidisciplinary evaluations (MDEs) in our region. MDEs, which include current medical, psychological, and social work evaluations, are ordered by a court to determine a person's need for guardianship.
- Vaya receives MDE referrals from county clerks of court, triages requests, and sends them to providers.

- Eligible providers must be enrolled in the Vaya network prior to service provision. Vaya offers an enhanced rate for this service. For more information, contact your provider network contract manager or <u>provider.info@vayahealth.com</u>.

## Service and Authorization Updates

# Update: Unbundling of Community Living and Support Service Codes

- In <u>Provider Communication Bulletin 2023-24, Issue 8</u> (Aug. 24, 2023), Vaya announced a change to authorization and claims guidelines for Community Living and Supports (CLS) services.
- Vaya's Care Management Department staff are reaching out to I/DD providers to begin unbundling the affected CLS codes for Innovations Waiver participants with plan start dates between Jan. 1, 2023 – Aug. 31, 2023. These codes include:

# Update: Unbundling of Community Living and Support Service Codes

- These codes include:
  - T2013 TF CLS Individual (requires Electronic Visit Verification [EVV])
  - T2012 CLS Individual (non-EVV), includes RADSE or when the service is provided only in the community
  - T2013 TF HQ CLS Group (requires EVV)
  - T2012 HQ CLS Group (non-EVV) when the service is provided only in the community
- As part of their outreach, Vaya Care Management staff will need to know which code(s) have been billed and which are likely to be billed later, based on the member's usage. They will use this information to ensure the member's budget reflects the changes.

# **Research-Based Behavioral Health Treatment Authorization Guidelines Updated**

- Vaya has updated our authorization guidelines for <u>Medicaid 1915(b) Research-Based Behavioral Health</u> <u>Treatment Services for Autism Spectrum Disorder (RB-BHT).</u>
- Please note that service code 97151 (Behavior Identification Assessment) now has a passthrough period of 32 units over a six-month period.
- Notification service authorization requests (SARs) are required but will be administratively approved beginning today, Oct. 5, 2023. Requests for more than 32 units must be submitted for medical necessity review.

### **New NC Medicaid Expansion Resources**

Starting Dec. 1, 2023, North Carolina is expanding Medicaid health coverage to more than 600,000

(available in Spanish and English), and a <u>sign-up form</u> to get updates about the expansion roll-out and
the enrollment process.



# **Engaging Child Welfare Involved Parents in Treatment Best Practice Guide Introduction**

- This group engaged with birth parents who had prior involvement with the child welfare system, and a key insight emerged: effective engagement with providers was pivotal for successful treatment and eventual reunification with their children.

By incorporating these proven practices, providers can significantly enhance the experiences of birth parents within the child welfare system, fostering successful treatment outcomes and ultimately reuniting families.

# **CPI Crisis De-Escalation Training for Children's and Youth Mental Health Providers in North Carolina**

 This free virtual verbal de-escalation training for children's and youth Mental Health providers in North Carolina will be facilitated by the Crisis Prevention Institute, which is an approved NC DHHS deescalation curriculum. CPI training opportunities will equip eligible providers with the skills to recognize potential crisis behaviors and the strategies to prevent, de-escalate, and safely respond in escalating and crisis situations. Priority will be given to providers working in residential settings, such as Residential Treatment Facilities and Therapeutic Foster Care.
