Contracting Opportunities: Parent-Child Interaction Therapy and Trauma-Focused CBT

Vaya is seeking providers with an interest in offering the following services:

Parent-Child Interaction Therapy (PCIT)

Vaya has received funding through the NC Division of Child and Family Welfare (DCFW) to expand PCIT in the following counties: Alamance, Alleghany, Ashe, Avery, Caswell, Chatham, Cherokee, Clay, Franklin, Graham, Haywood, Henderson, Jackson, Macon, Madison, Mitchell, Person, Polk, Rockingham, Rowan, Stokes, Swain, Transylvania, Watauga, Wilkes, and Yancey. We will be working to increase the number of rostered clinicians in our region with a focus on these counties, which currently have no rostered PCIT clinician.

PCIT is a short-term, specialized behavior management program designed for families with children ages 2-7 experiencing behavioral and/or emotional difficulties. PCIT emphasizes strengthening positive caregiver-child relationships while teaching caregivers how to appropriately manage the child's problematic behavior. Families receive weekly sessions with a therapist where the therapist works with the child and caregiver(s) together to improve overall behavior and reduce parenting stress.

PCIT training is provided through the <u>North Carolina Child Treatment Program</u>. Interested providers must be able to attend a PCIT training cohort prior to June 30, 2026.

Trauma-Focused Cognitive Behavioral Therapy (CBT)

Vaya is seeking providers interested in delivering Trauma-Focused CBT in the following counties: Alleghany, Ashe, Avery, Caswell, Cherokee, Clay, Franklin, Granville, Madison, Polk, Stokes, Swain, and Yancey.

TF-CBT is an evidence-based intervention for youth ages 3-18 and their non-offending caregiver. Research shows TF-CBT can successfully resolve a broad array of emotional and behavioral symptoms associated with single, multiple, and complex traumatic experiences.

TF-CBT training is provided through the <u>North Carolina Child Treatment Program</u>. Interested providers must be able to complete a TF-CBT Learning Collaborative prior to June 30, 2026.
