#### Submission and Reimbursement of Non-UCR Invoices

Please note the following guidance for non-UCR invoice submission:

- All non-UCR invoices for State Special Categorical expenses incurred through June 2 are due Monday, June 2, 2025.
- Non-UCR invoices for federal allocations for expenses incurred through May 31 are due by Monday, June 2, 2025.

For services rendered in June, Vaya requests that providers submit final non-UCR invoices no later than July 7, 2025, with an absolute deadline of July 20, 2025.

Per provider contracts with Vaya, providers must submit invoices for all non-UCR expenses within 45 days after the month in which the expenses were paid, except for services rendered in June of each year. For services rendered in June, providers must submit non-UCR invoices no later than July 20 of the same year, except for invoices funded with non-UCR State Special Categorical Funds.

Please use the current Vaya Non-UCR Invoice template for your submissions.

#### 2025 Provider Satisfaction Survey

# CFT Training: A Cross-System Training from the Family's Perspective July 14 – 15, 2025, 9 a.m. – 4 p.m.

This free, virtual course provides 11 contact hours of training related to System of Care and the Child and Family Team (CFT) process. It gives parents, caregivers, and professionals an overview of CFT meetings from the family's perspective and teaches strategies and facilitation skills to support youth and families.

To receive credit for the training, participants must attend both full days and have their cameras on with audio capability. Preference will be given to members/recipients and providers in the Vaya region. Only three individuals from each provider organization may register.
