Updated Record Management and Documentation Manual Available

The NC Division of Mental Health, Developmental Disabilities, and Substance Use Services has published a <u>new version of the Record Management and Documentation Manual</u> (RMDM).

The updated RMDM incorporates stakeholder feedback during State Fiscal Year 2023-24. NCDHHS <u>welcomes ongoing suggestions</u> to help ensure the manual continues to reflect the evolving landscape of North Carolina's public behavioral health and disability services system.

CFT Training: A Cross-System Training from the Family's Perspective July 14 – 15, 2025, 9 a.m. – 4 p.m.

This free, virtual course provides 11 contact hours of training related to the System of Care and the Child and Family Team (CFT) process. It gives parents, caregivers, and professionals an overview of CFT meetings from the family's perspective and teaches strategies and facilitation skills to support youth and families.

To receive credit for the training, participants must attend both full days and have their cameras on with audio capability. Preference will be given to members/recipients and providers in the Vaya region. Only three individuals from each provider organization may register.
