### Year-End Due Dates for Non-UCR Expenditures

On May 27, 2025, Vaya received the formal announcement from the NCDHHS Office of the Controller regarding deadlines for processing non-UCR payments for State Fiscal Year (SFY) 2024-25. Providers must submit any invoices for actual non-UCR expenditures incurred through May 31, 2025, to Vaya's Finance Department by the end of the day on June 2, 2025. Invoices for actual non-UCR expenditures incurred between June 1-2, 2025, also must be submitted to Vaya's Finance Department by this time to allow Vaya time to submit the Financial Status Report to NCDHHS by June 5, 2025.

Please note NCDHHS does not allow submission of estimated or projected non-UCR expenditures. To ensure reimbursement for any additional actual non-UCR expenditures incurred through June 30, 2025, Vaya requests providers submit final non-UCR invoices by July 7, 2025, with an absolute deadline of July 20, 2025.

Vaya Cohort PCIT Training: Notification of Interest Due Tomorrow

In partnership with the North Carolina Child Treatment Program (NCCTP), Vaya will offer an inperson Parent-Child Interaction Therapy (PCIT) training in July and October 2025 for providers in the Vaya region at no cost to providers. Participants must attend in both July and October.

Vaya will work directly with NCCTP to cover the cost of training. Funding is also available to cover travel expenses and facility/technology enhancements that providers may need to implement the model. There are still slots available in this cohort.
