## Sending PHI to Vaya: Important Reminders

In recent months, Vaya has seen an increase in privacy incidents involving provider employees and protected health information (PHI). To ensure both Vaya and network providers continue to protect member/recipient PHI, please review the following examples of privacy violations and best practices to maintain compliance with applicable laws, rules, and regulations, including HIPAA and the HITECH Act:

- Emails and faxes containing information related to an individual who is not a Vaya member/recipient: Before sending materials to Vaya, double check to confirm the information is related to Vaya members/recipients only.
- Emails with member/recipient information in the subject line: Do not add member/recipient information (including initials) to the subject line of an email. The subject line is never encrypted, and information contained within it is unsecured.
- *Provider Portal uploads to the incorrect member/recipient record:* Ensure you upload the correct documents to the right member/recipient profile.

## Updates to NC Medicaid Coverage for Wegovy, Zepbound

Effective Nov. 4, 2025, NCDHHS has removed the NC Medicaid Outpatient Pharmacy Prior Approval Criteria for GLP-1s – Wegovy and Zepbound. Until the revised clinical criteria for Wegovy and Zepbound are promulgated in accordance with NCGS § 108A-54.2(b)(2), NC Medicaid will cover Wegovy and Zepbound for clinical indications other than weight loss based on indications and uses approved by the U.S. Food and Drug Administration, which include:

- Reduction of the risk of major adverse cardiovascular events in adults with established cardiovascular disease and either obesity or overweight
- Treatment of noncirrhotic metabolic dysfunction-associated steatohepatitis (MASH) with moderate to advanced liver fibrosis in adults
- Treatment of moderate to severe obstructive sleep apnea in adults with obesity

Review the <u>NC Medicaid Bulletin</u> for more information. Please note effective Oct. 1, 2025, NC Medicaid no longer covers Wegovy and Zepbound solely for the treatment of obesity. If you have member-specific questions, call Vaya's Pharmacy Service Line at 1-800-540-6083.

# Forensic Assertive Community Treatment Offered in Buncombe County

RHA Health Services is piloting a new program, Forensic Assertive Community Treatment (FACT), in Buncombe County <u>as part of a new initiative at locations throughout the state</u>. A person-centered, trauma-informed service, FACT helps individuals who have severe mental health needs and are involved in the justice system to successfully reenter their communities while reducing their likelihood of reoffending.

FACT is deliverable 24/7 and provides time-unlimited support to address individual needs and help participants achieve their personal goals. To be eligible, individuals must:

- Be eligible for Assertive Community Treatment
- Have a medium-to-high risk of reoffending
- Be involved and/or have a significant history of involvement with the justice system
- Be a resident of Buncombe County
