Guidance on Accrued Funds under the NC Innovations Waiver IFDS Model

NC Medicaid has shared guidance on the use of accrued funds under the Innovations Waiver Individual and Family Directed Services (IFDS) model. Effective Jan. 1, 2026, health plans

managing Innovations Waiver services, Financial Support Service providers, and members participating in the IFDS model must adhere to the <u>IFDS Accrued Funds Policy</u>, which will be included in the revised version of NC Medicaid Clinical Coverage Policy 8P.

Peer Support Specialist Program Funding Opportunity

The North Carolina Certified Peer Support Specialist Program has announced a funding opportunity designed to strengthen the peer support workforce across the state. The program is seeking proposals to develop two new specialty training courses: Justice-Involved Peer Support and Crisis Response Peer Support. These specialty courses are designed to equip Certified Peer Support Specialists with advanced skills and knowledge to better serve individuals navigating complex life experiences.
