BEHAVIORAL HEALTH, I/DD, AND TBI PROVIDERS

Required Update for All HCBS Provider Contact Information

NC Medicaid is enhancing the Home and Community-Based Services (HCBS) Database to maintain compliance with the HCBS Final Rule and the Centers for Medicare & Medicaid Services-approved HCBS Final Transition Plan. All providers of HCBS in North Carolina must update their contact information to support this initiative.

Action Required by Feb. 13, 2026:

Vaya will email providers a spreadsheet with their HCBS site information by Jan. 9, 2026.

Complete the following steps to validate site information:

1. **Review** columns AF and AG (contact email and contact number) of the spreadsheet to identify any needed updates.
2. **Update** the contact information directly in the spreadsheet (if changes are necessary).
3. **Return** the completed spreadsheet to Vaya by **Feb. 13, 2026, even if no changes are required.**

Important Notes:

- **Do not** update the Provider Self-Assessment in the database directly.
- **Only** use the spreadsheet provided by Vaya.

Behavioral Health National Accreditation Requirements

NCDHHS has published an [NC Medicaid Bulletin](#) reminding behavioral health providers that national accreditation is required. Beginning Jan. 25, 2026, [NCTracks](#) will begin monitoring to verify provider compliance with N.C.G.S. § 122C-81. The requirements apply only to approved NC Medicaid State Plan services assigned to the Community/Behavioral Health taxonomy **251S0000X**.

Licensed Workforce Loan Repayment Program

NCDHHS is accepting applications for the Licensed Workforce Loan Repayment Program, a \$20 million initiative to help recruit and retain licensed professionals serving individuals with behavioral health disorders, I/DD, and/or TBI in rural and underserved communities. This program is part of the state's strategy to strengthen the behavioral health and human services workforce and increase access to care across North Carolina.

The program offers up to \$50,000 in student loan repayment. It requires a three-year service commitment in a rural or underserved county and is available to non-medical, licensed professionals who meet eligibility requirements.
